Please be aware that if you choose to supply your own alcohol you will need to deliver this directly to your caterer as we **do not accept ANY alcohol deliveries OR alcohol left in the marquee over night as it is NOT INSURED** and we cannot take responsibility for it.

Island Hall DOES NOT CHARGE CORKAGE and so you can choose to bring your own wine and enjoy a substantial saving, however all bars must finish service by: 20:00 within the house or 23:00 in the marquee.

If you choose to supply your own drinks from the Reception through to an Evening Bar. Costs to consider are: Wine & Water Waiters as well as chilling, extra glassware and removal of empty bottles.

Your caterer can directly supply uniformed wine waiters for your event at approximately £27.00 (inc. VAT) per guest.
